Decided that the workshop shall be on "Investment and Finance in Tourism Development" and Members shall communicate to the Secretary-General, in the light of their priority requirements at national level, the specific aspects to be covered at the workshop,

Decided further that the workshop shall precede the eleventh CAP meeting.

Decided further to nominate Indonesia as the representative of the East Asia and the Pacific region to the Study Group to be established by the Secretary-General to make a technical evaluation of the report "Harmonizing the contents and presentation of information material".
