The Commission,

Having considered the information document submitted by the Secretary General on the region's representation on the Executive Council and its subsidiary organs,

1. Decides to nominate for the Executive Council **Ecuador** and **Argentina and Peru as co-representatives** for the period 2014-2017: Argentina for the first biennium and Peru for the second. It was agreed that the floating seat for the same period would be shared by Jamaica and The Bahamas.
2. Thanks the candidates for the consensus they achieved.
3. Decides, lastly, to nominate **Jamaica** as its representative on the Committee for the Review of Applications for Affiliate Membership for the period 2014-2015.

2. Also decides to elect **Haiti** and **Mexico** as Vice Chairmen of the Commission for a two-year term (2011-2013); and
3. Expresses its sincerest thanks and appreciation to the outgoing Chairman, **Costa Rica**, and Vice Chairmen, **Peru** and **The Bahamas**, for their efficient and valuable leadership of the Commission.

ELECTION OF THE JURY FOR THE POSTER COMPETITION

Agenda item 5

According to par. 7 of Annex 2 to document A/20/Note Inf. 1, the Vettor Giusti Tourism Poster Competition is held in conjunction with each session of the General Assembly as an opportunity to highlight the creativity and beauty of posters used to promote tourism in different countries.

The People's Choice Award will be based on an online survey open to the public via the UNWTO website. All posters submitted in due form can be viewed on the UNWTO website right up to the announcement of winners during the Assembly.

A jury is to be formed composed of the Chairmen of the six UNWTO Regional Commissions, one representative of each of the two host countries (Republic of Zambia and Republic of Zimbabwe), a representative of the UNWTO Communication Program and a professional in the field of communication designated by the Organization.

The jury's final decision and the results of the public vote will be announced during the Assembly, and an official ceremony will be held to award the Vettor Giusti Prizes for 2013 to the winning countries.

In accordance with the applicable procedure, the Commission invited the Chairman (**Costa Rica**) to issue its opinion and transmit it to the Communications Program.

The poster chosen on this occasion had been submitted by **The Bahamas** and may be viewed on the UNWTO website until the next round of the Vettor Giusti Competition, to be held in conjunction with the General Assembly's session in 2015.

At the start of the meeting, the Secretary-General welcomed the delegations in attendance, and in particular Trinidad and Tobago, which had re-joined UNWTO. He expressed his confidence in the political stability of the region and its extraordinary economic recovery, which had helped reduce poverty in many countries over the past decade.

He called attention to UNWTO's role in ensuring that the tourism sector assumes its rightful place on the political agenda of many countries, helping to raise the sector's visibility and prominence.

He thanked Costa Rica for its initiative in asking countries of the region to consider the possibility of increasing the Organization's budget, a matter to be discussed in the Executive Council.

Lastly, he reminded the countries about the high-level meeting to be held among Ibero-American and Asian countries in conjunction with the General Assembly of 27 August 2013, jointly organized by the Ibero-American General Secretariat and UNWTO.

The member countries welcomed the results obtained in the elections conducted during the meeting and talked about the growing interest among countries in participating in UNWTO's principal organs.
