**PLACE AND DATES OF THE NINETEENTH SESSION  
OF THE GENERAL ASSEMBLY**

**Note by the Secretary-General**

In the following document the Secretary-General informs the General Assembly of the statutory and regulatory provisions governing the place and dates of its sessions and communicates the intention of the Government of the Republic of Korea to host its nineteenth ordinary session in 2011.

**PLACE AND DATES OF THE NINETEENTH SESSION  
OF THE GENERAL ASSEMBLY**

**I. PROCEDURE FOR FIXING THE PLACE AND DATES OF GENERAL ASSEMBLY SESSIONS**

1. The Articles of the Organization's Statutes and the Rules of Procedure of the Assembly concerning the place and dates of General Assembly sessions are reproduced below for information:

**(a) Article 8(2) of the Statutes:**

*"Meetings of the Assembly and the Council shall be held at the Headquarters of the Organization unless the respective organs decide otherwise."*

**(b) Rule 1 of the Rules of Procedure:**

- "1. The Secretary-General shall convene the Assembly in ordinary session every two years at the Organization's Headquarters.*
- 2. The Assembly may meet at another place if it so decides, provided the host country reimburses the extra expenses involved in holding the session.*
- 3. The date of the session shall be fixed by the Assembly or by the Council, if so empowered and notified to the Members of the Organization not less than seven months before it is due to be held."*

**(c) Resolution 351(XI) of the General Assembly**

By this resolution, the General Assembly adopted the procedure for the submission of candidatures by interested States, with particular regard to the timetable for the presentation of candidatures and the signature of agreements between the host State and the Organization.

### **III. CANDIDATURE RECEIVED FOR THE NINETEENTH SESSION**

3. The Government of the Republic of Korea officially informed the Secretary-General a.i. on 16 September 2009, of its strong interest in hosting the next session of the General Assembly.

4. The Republic of Korea is a member of the UNWTO Commission for East Asia and the Pacific. The General Assembly has not met in this region since 2003 (Beijing). Consequently, in the absence of an invitation from a country of the Middle East and South Asia regions, this candidature appears satisfactory in view of the wish expressed in resolution 443 (XIV) to maintain a certain geographical balance among the different regions.

5. In accordance with the rules established for hosting a General Assembly session, the Secretary-General a.i. asked this country to confirm its intention and to say whether it is prepared to accept the conditions laid down for holding an Assembly session in its territory.
