The General Assembly,

Having considered the report of the Secretary General on the *Roadmap for Recovery – Tourism & Travel as a Primary Vehicle for Job Creation and Economic Recovery: Sustainable Tourism in Challenging Times*,

1. Commends the Secretary-General for the information provided on the impact of the global economic crisis on world tourism, on the stimulus measures developed by national governments to support tourism in these challenging times and for the presentation of the *Roadmap for Recovery*;
2. Expresses its appreciation to the Tourism Resilience Committee, chaired by the Minister of Tourism of Egypt, H.E. Mr. Zoheir Garranah, and the Core Group of the Committee, chaired by H.E. the Australian Ambassador to Spain, Mr. Noel Campbell, for the work developed since the creation of the Committee by the Executive Council at its 84th Session (October 2008), particularly in regards to the work on the *Roadmap for Recovery*;

3. Appreciates with satisfaction the timely and accurate response of the Organization to the current global crisis and the activities developed in this framework by the Tourism Resilience Committee, particularly the *Roadmap for Recovery*;

Recalling that, though resisting better than many other economic sectors, tourism has not been immune to the global recession that has affected the economies worldwide, and that in 2009 international tourism is forecast to decrease by between 6 per cent and 4 per cent,

4. Endorses the *Roadmap for Recovery* (A/18/8), and its recommendations, as the Organization's position paper on tourism in face of the short and long term challenges, including resilience, stimulus programmes and the transformation to a Green Economy;
  5. Underlines that stimulus actions taken to boost promotion, simplify regulations, build infrastructure, rationalise taxes and facilitate travel, which in turn encourage companies to invest, innovate and stimulate demand, will help build resilience and promote recovery, not only in the tourism sector but across economies, and therefore appeals all members to consider the recommendations of the *Roadmap for Recovery* for adoption and implementation;
  6. Stresses the role and potential that tourism can have, together with other sectors, in the transformation to a new development model in the framework of the Green Economy and the response to Climate Change, as well as towards achieving the Millennium Development Goals (MDGs), in particular regarding poverty alleviation;
  7. Encourages the Secretary-General to work closely with Member States and to seek collaborative multi-stakeholder engagement for the promotion and implementation of the *Roadmap* and its message – Tourism & Travel: a primary vehicle for job creation and economic recovery – in order to consolidate the role of tourism as a key player in the global agenda; and
  8. Prompts Members to promote the *Roadmap* to key decision makers at national, regional and global levels and provide feedback to the Secretariat on measures to implement the Roadmap.

Having taken cognizance of document A/18/10,

Recalling that coordination mechanisms serve, in particular, the important functions of avoiding duplication and promoting complementarities between the UNWTO's programmes and activities, and those of other UN agencies and coordination mechanisms,

Considering that, given the small size of its Secretariat and budget, UNWTO is likely to benefit from its partnership with other UN institutions, and from the access to resources of the UN system at no cost for the Organization,

1. Takes note with interest of the participation of UNWTO on a regular basis in the three most senior coordination mechanisms of the United Nations System, namely, the Chief Executives Board for Coordination (CEB), the High Level Committee on Programmes and the High Level Committee on Management, as well as in those dealing with UN Administrative Issues and in others that are of specific interest to the Organization;

2. Appreciates with satisfaction the successful coordination achieved with the UN related bodies, especially the UN Statistical Commission and the International Labour Organization, for the holding of the 5<sup>th</sup> International Conference on Tourism Statistics, in Bali on April 2009, which this year focused on employment issues;
  3. Notes that the following meetings have been hosted at the UNWTO Headquarters, thus strengthening its insertion within the UN system: the United Nations International Task Team on HIV-related Travel Restrictions in June 2008; the 5<sup>th</sup> UN Inter-Agency Travel Network (IATN) in October 2008; and the 17<sup>th</sup> session of the UN Human Resources Network (HR Network) in March 2009;
  4. Welcomes the active role played by UNWTO in introducing the issues relating to Climate Change and Tourism within the broader UN agenda on Climate Change, and requests the Secretary-General to continue to convey the concerns and the initiatives of the tourism sector on this issue, for them to be taken into account within the UN framework, especially the United Nations Framework Convention on Climate Change (UNFCCC);
  5. Congratulates the UNWTO Secretariat for the inclusion of the tourism perspective in other substantive issues dealt with by the United Nations, and in particular: poverty alleviation, crisis management, H1N1 influenza preparedness, contribution of tourism to sustainable development and employment, inter-cultural dialogue and gender issues;
  6. Welcomes the approval, on 29 April 2008, by the United Nations Economic and Social Council of the draft annex relative to the Organization concerning the privileges and immunities of the specialized agencies and takes note that the Executive Council approved the text of the annex at its eighty-third session pursuant to the mandate it received from the General Assembly through resolution 545(XVII);
  7. Joins the United Nations in the action it has undertaken with a view to encouraging the States that have not yet done so to ratify the Convention on the Privileges and Immunities of the Specialized Agencies, and in particular, to accede to the new annexes – including that relating to the UNWTO; and
  8. Welcomes the initiatives and projects developed by the International Task Force on Sustainable Tourism Development, which was established within the framework of the Marrakech process and its forthcoming transformation into a broad UN partnership.

  4. Also thanks the UNWTO Secretariat for having generously provided the national focal points and the Regional Coordination Office with supplementary office equipment to facilitate the coordination and follow-up of the activities of the project;

1. Notes with satisfaction that the programme proposed is built upon strategic and specific objectives that respond to the Members' priority needs and also to wider commitments with the UN System;

3. Advocates, in the light of the still difficult global economic situation, for clear leadership by UNWTO in providing information, analyses and policy direction for Member States to help them manage their tourism industry through the crisis;
4. Supports, therefore, the Programme Committee's recommendation that the Secretary-General establishes a contingency mechanism for special activities or unexpected events that may arise after the approval of the draft programme by the General Assembly and that may require UNWTO intervention;
5. Expresses its satisfaction with the way in which the Secretariat has prepared the draft programme, including a detailed and clear consultation process with all Members and a constant and fruitful collaboration with the Programme Committee and the Committee on Budget and Finance, reinforcing the Member States' ownership regarding the work of the Organization;

6. Requests the Executive Council to review the role of its technical committees with a view to better define their functions as subsidiary bodies, especially in relation with the preparation, implementation and evaluation of the programme of work of the Organization;
7. Thanks the Secretary-General for having proceeded, following the Executive Council decision 13 (LXXXV), to a notable reduction of the draft budget presented to its eighty-fifth session;
8. Approves the draft programme of work, as recommended by the Council at its eighty-sixth session;
9. Adopts a draft programme and budget for 2010-2011 amounting to a total of 25,200,000 euros, resulting from the application of Zero Nominal Growth to individual country contributions for 2009, and adjusted by any modification in membership that may occur;
10. Authorizes the Secretary-General to execute the programme of work and budget for 2010-2011 in accordance with the amounts collected, in line with the satisfactory budgetary practice established in previous biennia and the proposals contained in document A/18/15;
11. Supports the proposal of the Secretary-General to reinforce extra-budgetary funded activities, and in particular, the African initiative of a public-private partnership to mobilize resources for tourism-related projects linked to the Millennium Development Goals and poverty reduction through sustainable tourism in Africa;

Taking into account the recommendation formulated by the Executive Council in its decision 8(LXXXV) on the use of the surplus resulting from the financial period 2006-2007, which amounts to 830,993.50 euros,

12. Authorizes the Secretary-General to use this surplus to establish a special contingency account, to cover extraordinary and unavoidable expenses, such as post-separation liabilities of the Organization, subject to the terms stipulated in the annex 4 of document A/18/15; and
  13. Commends the Committee on Budget and Finance, the Programme Committee and their Chairpersons for their valuable contributions to the preparation of the Organization's draft programme of work for 2010-2011.

Requests the Secretariat to elaborate proposals for a possible revision of the formula for determining country contributions, i.e. the "Lusaka formula", in order to better reflect the financial possibilities of less developed countries and achieve greater fairness in contributions, and to have this proposal discussed by the Committee on Budget and Finance before a final recommendation is made to the Executive Council and the General Assembly;

Considering that the approved budget for the next financial period amounts to 25,200,000 euros,

6. Decides that the budgetary income approved for the next period should be provided by the contributions of the Full and Associate Members in the amounts of 11,212,999 euros for 2010, and 11,212,999 euros for 2011, and that the balance to be financed should be covered by the contributions of the Affiliate Members and the other sources of funding referred to in document A/18/15;

7. Agrees that, in accordance with resolution A/RES/526(XVII), the contributions of the Associate Members be divided into two separate categories, each being 10% lower than the contribution of the Full Members in groups 13 and 9 respectively; and
  8. Also decides to accept the Secretariat proposal as recommended by the Executive Council to maintain the contribution of the Affiliate Members at 2,400 euros per year for the period 2010-2011.

2. Encourages the Secretariat, based on the conclusions of the Silk Road meeting celebrated in the framework of this session of the Assembly, to set up two working groups in order to deal with barriers removal, visa facilitation, infrastructure development, marketing and promotional activities;
3. Invites the Secretary-General to report on progress made on the development and implementation of the aforementioned recommendations to its nineteenth session in 2011; and
4. Adopts the attached Astana Declaration;

**ANNEX****ASTANA DECLARATION**

Gathered in Astana (Kazakhstan), in a country that in past times was traversed by the ancient and legendary Silk Routes, the representatives of the countries participating in the eighteenth session of the General Assembly of the World Tourism Organization (UNWTO),

Making reference to the Statutes of the World Tourism Organization and to the Global Code of Ethics for Tourism, which underline the role of this activity as a factor of economic and social development, but also as a vehicle for peace, understanding, cultural enrichment, environmental preservation and dialogue among peoples,

Aware of the exceptional value and diversity of the tourism potential, both cultural and natural, of the countries that in the past were traversed by the ancient Silk Routes,

Underlining the importance of the initiative of the World Tourism Organization and of the United Nations system, which for fifteen years now has aimed to revive the ancient Silk Road as a supporting element of the tourism development of the immense region of Eurasia and the Middle East,

Recalling the commitment of 24 countries in favour of this initiative and calling upon the other members of the UNWTO that are interested to join it or to provide their support to it,

Recalling the declarations of Samarkand (1994), Khiva (1999) and Bukhara (2002), as well as the conclusions of the meetings organized by the UNWTO on the subject of the Silk Road in Xian (China) in 1996, Nara (Japan), Tehran (Iran) and Istanbul (Turkey) in 1997, Kyoto (Japan) and Almaty (Kazakhstan) in 1998, Beijing (China) in 2003, and once again in Almaty in 2008,

Underlining the growing interest of local authorities, and, in particular, of the representatives of the cultural and touristic cities situated along the Silk Road, as manifested by the Mayors' Forum held in Almaty in September 2008,

1. Welcome the success that the raising of the subject of the Silk Road has already met among operators of the tourism sector as well as among the media and the general public;
2. Underline the remarkable capacity for growth and for the sustainable development of products based on the cultural and ecological riches of the sites and attractions that lie all along the 12,000 kilometres of the ancient Routes;

3. Draw the attention of governments to the obstacle posed to visitors who wish to discover these riches by the multiplicity of visas and administrative procedures that make it difficult to cross borders, and request the UNWTO Secretary-General to take all necessary initiatives in consultation with the pertinent administrations of countries concerned on this issue;
  4. Express their wish for the UNWTO to continue to support the promotional efforts aimed at enhancing the visibility and market access of the Silk Road destinations among the professionals of the countries that generate tourists who travel to these destinations;
  5. Lend their support to the initiatives of the municipal and local authorities, based on public-private partnership, aimed at building new tourism attractions themed on the Silk Road;
  6. Request the UNWTO Secretary-General a) to further increase the effectiveness of the means the Secretariat of the Organization applies in favour of the initiative, b) to strengthen the coordination among Member States and c) to revisit the cooperation agreement with the Support Office opened in Samarkand in 2004, with the assistance of Uzbekistan, in line with the current review process concerning all UNWTO external entities, and with a view to further supporting the Silk Road Initiative;
  7. Appeal to the United Nations agencies and programmes, in particular the United Nations Development Programme (UNDP) and UNESCO, which have shown interest in the initiative on various occasions, to lend it stronger support in conjunction with the UNWTO; and
  8. Decide to once again discuss this subject and to take stock of the progress made, on the occasion of the nineteenth session of the General Assembly of the World Tourism Organization in 2011.

The General Assembly,

Having taken cognizance of the report of the Secretary-General on this matter,

Having before it the preliminary outcome of the second survey on the implementation of the Global Code of Ethics for Tourism, carried out among UNWTO Members between September 2008 and May 2009,

Having been informed of the inauguration on 14 November 2008 in Rome, Italy, of the Permanent Secretariat of the World Committee on Tourism Ethics,

Pursuant to its resolution A/RES/532(XVII) through which it entrusted the Committee “with the formulation of an appropriate procedure for the two-phased renewal of its seats and the recommendation on the members to be replaced in 2011, for approval at the eighteenth session of the Assembly”,

Having before it the amended text of the Rules of Procedures approved by the World Committee on Tourism Ethics in June 2009,

1. Welcomes the election of Mr. Dawid de Villiers as Chairman of the World Committee on Tourism Ethics for a four-year term ending with the General Assembly of 2011;
2. Notes with appreciation the initiatives taken by the Committee to promote the Global Code of Ethics for Tourism and to advance its implementation by governments, the tourism industry and other stakeholders;
3. Thanks the Italian Government for the establishment of the Permanent Secretariat of the Committee and for the support provided for its operations, and recommends that the central task of the Permanent Secretariat should be to strengthen the promotion and dissemination of the Code of Ethics through the design and launch of an effective global awareness-raising campaign;

4. Notes with satisfaction the adoption of a new logo for the Global Code of Ethics for Tourism, which should facilitate the global strategic positioning of the Code of Ethics and enhance its visibility worldwide;
5. Expresses its disappointment with the low response to the recent Implementation Survey on the Code of Ethics and calls upon Member States, Affiliate Members and other stakeholders from the private sector and educational institutions to pursue and consolidate the implementation of the Code and to report back thereon to the World Committee on Tourism Ethics, so as to enable the latter to provide the General Assembly of the United Nations (at its 65<sup>th</sup> session of 2010) with a complete and up-to-date information on the specific actions and measures taken by governments and the tourism industry with a view to incorporating ethical and responsible policy and business practices into overall tourism activities;
6. Takes note of the amendments to the Rules of Procedure approved by the Committee at its eighth meeting in Costa Rica;
7. Requests the Committee to amend its Rules of Procedures at its next session, so that the Permanent Secretariat of the Committee attends *ex-officio* the meetings of the Committee and is associated in the preparation of the provisional agenda of its meetings,
8. Further welcomes the election by the members of the Committee of Ms Christel DeHaan as Vice-Chairperson of the Committee following the adoption of the revised Rules of Procedure;
9. Adopts the following amendment to resolution A/RES/438(XIV) -as amended by resolution A/RES/469 (XV)- which should enable the staggering of the renewal of the Committee to begin with an election process scheduled to take place throughout spring 2011:  
  
*“The members of the Committee and their alternates are re-elected by half every two years. During the session of the General Assembly in 2011, a total of eleven of the current members of the Committee will have their mandate extended for two more years; while the other eleven members or alternates will be elected for a full mandate of four years”.*
10. Expresses its gratitude to the Governments of Italy and Costa Rica for having hosted the seventh and eighth meetings of the Committee, in Rome (November 2008) and San José (June 2009), respectively;

**Declaration on the facilitation of tourist travel**

Agenda item 20

The General Assembly,

Having taken cognizance of the report of the Secretary-General on this matter,

Having before it the Declaration on the facilitation of tourist travel approved by the Executive Council at its eighty-fifth session,

1. Approves the attached text of the Declaration;
2. Recognizes that the Declaration is of a purely recommendatory nature and has no binding force and is conscious that the facilitation of tourist travel is a continuous process, which should be under periodic review;
3. Requests the Secretary-General to disseminate the Declaration to countries, the media and other interested parties;

4. Entrusts the Secretary-General of UNWTO to:
  - (a) seek advice from the World Committee on Tourism Ethics to further examine ways to facilitate tourist travel;
  - (b) promote the principles set in the Declaration, including the use of modern information and communication technologies, in relation with travel advisories and visa facilitation;
  - (c) encourage all possibilities of organizing information exchanges, training sessions and other activities beneficial to all Member States and to provide them with technical assistance if they so require;
  - (d) advise UNWTO Member States to encourage all stakeholders in tourism to observe and follow the recommendations contained in this Declaration;  
and
  - (e) report to its the next session on the follow up of the present Declaration.
5. Warmly thanks the members of the Working Group for the work they have accomplished and pays tribute to Ms. Blanka Belosevic for her performance as Chair of the Group on behalf of Croatia.

## **A N N E X**

### **DECLARATION ON THE FACILITATION OF TOURIST TRAVEL**

The General Assembly of the World Tourism Organization,

*Convinced* that the facilitation of tourist travel contributes to the development of the tourism sector and, beyond that, to international understanding, peace, prosperity, and universal respect for and observance of human liberties, without distinction as to race, gender, language or religion, in accordance with the mission of the World Tourism Organization (UNWTO),

*Considering* that, despite the great strides made in recent decades in facilitating tourist travel, there is still room for considerable progress in this area in the interests of all stakeholders in tourism development,

*Bearing in mind* its earlier resolutions on the facilitation of tourism development, and in particular resolutions 139 (V), 180 (VI) and 243 (VIII), as well as the Global Code of Ethics for Tourism,

*Concerned* about the need to further facilitate tourist movements throughout the world,

#### **DECLARES THE FOLLOWING:**

1.1. Member States of UNWTO and all tourism stakeholders should take all possible measures to facilitate tourist travel.

1.2. To that end, they commit to consider all possible means to eliminate or reduce barriers to tourist travel of a legal, financial, or technical nature that are not strictly indispensable to maintain security, safety, health and public order.

1.3. Member States of UNWTO, undertake to give priority consideration to measures to facilitate tourist travel and to encourage all tourism stakeholders to do so, especially in the following areas:

- Travel advisories;
- Visa issuance modalities (with the exception of basic conditions for such issuance, which do not fall within the mandate of UNWTO);
- Tourist travel by persons with disabilities;
- Tourist travel by persons affected by the HIV virus.

## **2. Travel Advisories**

2.1. *Aware* that travel advisories have an undeniable role to play in providing useful information to protect citizens when travelling abroad, the General Assembly also acknowledges that they can have serious consequences for tourism activity and the economies of countries and destinations.

2.2. The General Assembly therefore reaffirms the provisions of paragraph 5 of Article 6 of the Global Code of Ethics for Tourism:

“Governments have the right – and the duty - especially in a crisis, to inform their nationals of the difficult circumstances, or even the dangers they may encounter during their travels abroad; it is their responsibility however to issue such information without prejudicing in an unjustified or exaggerated manner the tourism industry of the host countries and the interests of their own operators; the contents of travel advisories should therefore be discussed beforehand with the authorities of the host countries and the professionals concerned; recommendations formulated should be strictly proportionate to the gravity of the situations encountered and confined to the geographical areas where the insecurity has arisen; such advisories should be qualified or cancelled as soon as a return to normality permits”.

2.3. UNWTO Member States issuing travel advisories in respect of third countries, are called upon to commit to consult as widely as possible with the governments of these countries and destinations, especially on the safety and security aspects of each tourist region in the country, and to update the relevant information at regular intervals, at least every six month.

2.4. The General Assembly also reaffirms the full validity of the guiding principles for official travel advisories attached to its resolution 508 (XVI), adopted during its session in Dakar, Senegal, (2005) and, in addition, calls upon Member States to consider other relevant recommendations issued by other competent organizations.

## **3. Visa issuance**

3.1. The General Assembly reaffirms the sovereign right of States to control the access of foreign nationals to their territories—notably by means of visa policies, which they have the authority to determine freely, unilaterally, or in cooperation with other States. The General Assembly recognizes the discretionary authority of States in this regard, yet it considers that improving visa issuance modalities could help facilitate tourist travel significantly.

3.2. *Convinced* that tourist travel could be greatly facilitated by measures that can be implemented easily and without detriment to this discretionary authority, the General Assembly calls upon Member States, whenever possible and taking consideration of the respective legislation, to adopt measures to simplify visa application and processing formalities and to improve the timeliness of visa issuance,

#### 4. Persons with disabilities

4.1. *Deeply convinced* that the facilitation of tourist travel by persons with disabilities is a major element of any responsible tourism development policy.

4.2. *Bearing in mind* the Preamble of the United Nations Convention on the Rights of Persons with Disabilities of 30 March 2007, which recognizes "the importance of mainstreaming disability issues as an integral part of relevant strategies of sustainable development", the General Assembly recalls that responsible tourism is a necessary component of such strategies and that great efforts should be made to ensure that tourism policies and practices are inclusive of persons with disabilities, the majority of whom live in developing countries.

4.3. The General Assembly furthermore solemnly reaffirms the principles it enunciated at its session in Buenos Aires, Argentina, in 1991 (A/RES/284(IX), entitled "Creating Tourism Opportunities for Handicapped People in the Nineties."), and which were updated at its session in Dakar, Senegal, (in resolution A/RES/492(XVI), entitled "Accessible Tourism for All") and again calls upon all States:

- to make their tourism sites and establishments accessible to persons with disabilities and to offer them special facilities at no additional charge to them;
- to offer special training to the staff of tourism sites and establishments and tourism-related services, preparing them for work with persons with disabilities; and
- to publish clear and detailed information on existing receptive facilities for persons with disabilities as well as the problems they may encounter during their tourist travel.

4.4. It also endorses the general principles enshrined in Article 3 of the Convention on the Rights of Persons with Disabilities and invites all States to implement them. It also draws attention to the work which is being done by the Inter-Agency Support Group for the Convention.

4.5. It requests the Secretary-General of UNWTO:

- to consult with representative non-governmental organizations active in the area of assistance for persons with disabilities in order to determine more precisely what role UNWTO could play in this field and to communicate the results of these consultations to the Executive Council; and
- to arrange for the UNWTO to be represented at meetings of the Committee on the Rights of Persons with Disabilities when it examines the provisions of the *Convention on the Rights of Persons with Disabilities* relevant to the UNWTO's mandate.

## 5. Persons affected by the HIV virus

5.1. *Concerned* by the restrictions on tourist travel by persons affected by the HIV virus, the General Assembly decides to remain seized of the matter, taking into account the recommendations of the World Committee on Tourism Ethics.

## 6. Finally

6.1. While the present Declaration is of a purely recommendatory nature and has no binding force, the General Assembly is conscious that the facilitation of tourist travel is a continuous process, which should be under periodic review.

6.2. To this end, the General Assembly entrusts the Secretary-General of UNWTO to:

- (b) seek advice from the World Committee on Tourism Ethics to further examine ways to facilitate tourist travel;
  - (b) promote the principles above, including the use of modern information and communication technologies, in relation with travel advisories and visa facilitation;
  - (c) encourage all possibilities of organizing information exchanges, training sessions and other activities beneficial to all Member States and to provide them with technical assistance if they so require;
  - (e) advise UNWTO Member States to encourage all stakeholders in tourism to observe and follow the recommendations contained in this Declaration;  
and
  - (e) report to its the next session on the follow up of the present Declaration.
