##### Addendum 1

Further to document A/19/10(g), the following agreements concluded by the Organization were registered.

#### I. AGREEMENTS CONCLUDED WITH GOVERNMENTS AND INTERGOVERNMENTAL ORGANIZATIONS

- 22 January 2010: [English] Memorandum of understanding between the **Vietnam** National Administration of Tourism and the World Tourism Organization to strengthen the collaboration between them and exchange views on potential UNWTO assistance to Viet Nam in the areas of tourism investment and infrastructure, promotion and marketing, as well as human resource development.
- 25 July 2011: [English and Armenian] Memorandum of understanding between the World Tourism Organization and the Government of the Republic of **Armenia** to cooperate and implement joint activities in the sphere of tourism in the South Caucasus geographical space, and in the Silk Road, for tourism policy and governance.
- 31 August 2011: [Spanish] Administrative agreement between the World Tourism Organization and the Tourism Institute of Spain (TURESPAÑA), of the General Secretariat of Tourism and Domestic Trade of the Ministry of Industry, Tourism and Trade, for the sustainment of the Permanent Secretariat of the Affiliate Members at the Headquarters of the Organization in 2011-2012.
- 15 September 2011: [English] Memorandum of understanding between the **United Nations Alliance of Civilizations (UNAOC)** and the World Tourism Organization (UNWTO) to formalize the support of UNWTO for the accomplishment of the mission established for the Alliance of Civilizations, to formalize understanding and cooperative relations among nations and peoples across cultures and religions, notably between Western and Muslim societies, and to help counter the forces that fuel polarization and extremism.

## II. AGREEMENTS CONCLUDED WITH LOCAL AUTHORITIES

- 22 July 2010: [English and Chinese] Memorandum of understanding between the World Tourism Organization and the **Huangshan Municipal Government (China)** to further collaborate and work in a productive and enduring partnership.
- 13 October 2010: [English and Chinese] Memorandum of understanding between the Regional Programme for Asia and the Pacific of the World Tourism Organization and the **Tianjin Municipal Tourism Administration (China)** to expand the current cooperation on tourism in general and to co-organize a high-level training programme for tourism officials in Asia and the Pacific.
- 2 September 2011: [English and Chinese] Memorandum of understanding between the World Tourism Organization and the **Tianjin Municipal People's Government (China)** to enhance cooperation between the UNWTO and Tianjin and with a view to advocating the United Nations Millennium Development Goals through sustainable tourism development, mainstreaming tourism in the government agenda of Tianjin and facilitating Tianjin's efforts to transform itself into an international tourism destination.

## III. AGREEMENTS CONCLUDED WITH LOCAL PUBLIC ENTERPRISES

- 1 January 2011: [Spanish] Specific protocol between the World Tourism Organization, through the Secretariat of the Affiliate Members and the State Company for State Company for Tourism Technology and Innovation Management (**SEGITTUR**) (**Spain**), for the development of a networked public-private technological platform for tourism intelligence and innovation (PLATMA), as a renewal of the specific protocol signed on 3 June 2010.

## IV. AGREEMENTS CONCLUDED WITH NON-GOVERNMENTAL ORGANIZATIONS

- 11 April 2011: [English] Memorandum of cooperation between the Regional Programme for Asia and the Pacific of the World Tourism Organization and the **World Hotel Association of China** to advocate the United Nations Millennium Development Goals through sustainable tourism development with the support of the private sector, to advocate and promote the Global Code of Ethics for Tourism through the private sector, and to promote the sustainable development of the hotel industry especially in Asia and the Pacific.
- 10 September 2011: [English] Memorandum of understanding between the World Tourism Organization and the **Latin American Association of Development Financing Institutions (ALIDE)** to enhance cooperation between UNWTO and ALIDE and to identify areas of mutual interest.

## V. OTHER AGREEMENTS

- 18 July 2011: [English] Cooperation agreement between the World Tourism Organization and the **International Network on Regional Economics, Mobility and Tourism (INROUTE)** Association for the development of official guidelines for entities involved with regional & local tourism destinations.
- 16 September 2011: [English and Spanish] Framework cooperation agreement between the World Tourism Organization, the **ONCE Foundation and the European Network for Accessible Tourism (ENAT)** for the establishment of general modes of collaboration for

the best possible use of human and material resources in common, related or complementary fields of activity of mutual interest.
