Report of the Secretary-General

(a) Financial situation of the Organization

I. Financial situation as of 31 July 2012

- As of 31 July 2012, and in view of the level of contributions received, the overall plan of income and expenditure established by the Secretary-General shows no difference with respect to the previous expenditure plan at 31 May 2012 submitted to the Executive Council in document CE/93/5(b) Add.2.

2. Income as of the end of July remains lower than in previous years at this time. This deceleration appears confirmed for current-year contributions, to the point that a decrease in the target for the year by 150,000 euros is made. By contrast, better-than-expected performance in arrears could offset that decrease, although this income source is more volatile. Therefore, the estimated contribution income for the current year has been revised downward by 150,000 euros compared to the previous estimate (from EUR10,263,000 to EUR10,113,000), while the estimate of revenue arrears has been corrected upward by the same amount (from EUR1,000,000 to EUR1,150,000), keeping the estimated total revenue at the same level as the estimate made at 31 May, i.e., EUR12,148,000.

3. Income receipts at 31 July 2012 amount to EUR10,224,987.47 and represent 84% of the income estimates (EUR12,148,000) as shown in the plan of income and expenditure. The level of contribution receipts for the current year amounts to EUR8,465,595.67 which represents 71% of the assessed contributions and 84% of the estimated contributions, and is slightly lower than in the two preceding years for the same period. However, arrear contributions received to date (EUR874,391.80) are at a high level.

4. The estimated expenditure level remains at EUR12,148,000. The implemented expenditure as of 31 July 2012 amounts to EUR11,642,908.83 representing 96% of the estimated expenditure, out of which EUR6,722,086.95 have already been effected, furthermore EUR4,920,821.88 are already committed until year end (staff costs included). The percentage of implemented expenditure as of the same date in 2010 and 2011 amounted to 90% and 91% respectively, which continues to indicate the budgetary pressures on UNWTO's programs in line with the zero nominal growth policy of the Organization, already followed for a period of four years, limiting the Organization's flexibility in implementing its Programme of Work.

5. Taking into account the expenditure implemented, the balance between income and expenditure shows a deficit of EUR1,417,921.36, even though there is an excess treasury of EUR3,502,900.52 if we only consider disbursements already carried out.

6. In view of disbursements made and income and expenditure forecasts until the end of the year, it appears that the income and expenditure plan for 2012 is on track.

III. Voluntary contributions

9. As of the date of this document, euro-denominated voluntary contributions amounting to EUR1,435,758.95 have been received, as well as USD-denominated voluntary contributions amounting to USD1,415,200.08. A statement of voluntary contributions received in 2012 is shown in Annex II.

IV. Detailed Financial Rules (DFR) second draft amended

10. In line with the progress made on the IPSAS project, an amended second draft is included as Addendum 1 to this document.

V. Actions to be taken by the Executive Council

11. The Executive Council is requested:

- (a) To take note of the level of collection of contributions from Members for the financial year 2012 as of 31 July 2012, amounting to EUR8,465,595.67 estimated income, and also of the collection of contributions in arrears, amounting to 874,391.80 euros;
- (b) To urge Members that have not yet complied with their financial obligations to take the necessary steps to pay their contributions for 2012, thereby averting delays that could hamper programme execution;
- (c) To take note of the budgetary pressures experienced by the Organization due to the zero nominal growth policy already followed for a period of four years, while noting with satisfaction the prudent financial management exercised by the Secretary-General; and
- (d) To approve the second draft amended Detailed Financial Rules (DFR) necessary for compliance with IPSAS as proposed by the Secretary-General, including wording amendments proposed on the Replacement Reserve under DFR 6.21 and 6.23, and, to encourage the Secretary-General to continue to advance in the third draft amended Detailed Financial Rules (DFR) necessary for compliance with IPSAS.
