GENERAL INFORMATION NOTE

1. The organizers of INVESTOUR; Casa África, Feria de Madrid (IFEMA) and the World Tourism Organization (UNWTO), are organizing the first INVESTOUR workshop on Financing in the tourism sector ahead of the 9th edition of INVESTOUR, and is scheduled to take place 16 and 17 October 2017, in Las Palmas de Gran Canaria in Spain. This workshop will provide the information and tools necessary to successfully facilitate the financing of small-scale, sustainable tourism projects, and to transfer these skills to public and private stakeholders in the tourism sector. The workshop is open to Member States and stakeholders from the Africa region.

III. STATUS OF PARTICIPANTS

3. The Canary Islands authority will take the necessary steps to facilitate the arrival and departure of participants invited by the Organization as well as their stay in Canary Islands. Throughout their stay, participants will enjoy the privileges and immunities provided for in the Convention on the Privileges and Immunities of the United Nations of 13 February 1946.

IV. ENTRY FORMALITIES

4. A valid passport is required for visitors to Spain. Entry visas may be obtained at Spain's diplomatic and consular representations abroad.

5. The Government of Spain will grant visas to all delegates attending the workshop, upon presentation of the letter of invitation at the corresponding Embassy of Spain, in accordance with Spanish legislation. Casa África will provide each participant with an invitation letter.

Important note: Due to European Union regulations, **NO visas-on-arrival can be issued**. Participants are kindly requested to make the necessary arrangements to obtain their visas beforehand.

VIII. HEALTH REQUIREMENTS
