ADOPTION OF THE AGENDA

The Commission

- 1. Adopts the agenda of its fifty-ninth meeting, as contained in document CEU/59/Prov. Agenda.

Notes with appreciation several important upcoming activities, including World Tourism Day on the theme of "One Billion Tourists, One Billion opportunities" (27 September 2015), the UNWTO / Ministers Summit in WTM on "Destination Branding: new challenges in a changing market" (3 November 2015), the "Tourism and Media" Conference to be held in Tunisia (12-13 November 2015) and the 12th edition of the UNWTO Awards;
- 7. <u>Accepts</u> the invitation to support, through their representations to the UN, the proposal presented by UNWTO to the UN General Assembly of declaring 2017 as the "International Year of Sustainable Tourism for Development".
